The Wheeler Crest Community Services District would like to **thank all of you** for your effort in reducing our water usage this past year. We are under a State mandate to reduce water consumption by 25%.

This past year has been challenging for all. The need to rebuild for some and the desire to replant and be surrounded by some sense of “normal” vegetation for others. However, although this winters’ snow level is “normal”, we are still way below the amount of water/snow required to pull us out of this drought. So we thank you for remaining vigilant in your water conservation effort. We would like to remind you that come spring, the mandatory restriction for outdoor watering is still limited to two days. **Hilltop Well** - The “new” Hilltop well was in full operation this past year and did not encounter a single failure. There were several outages caused by the cutting of underground pipes in the re-building of various structures after the fire. But overall, this past year was the most stable in recent years. Once again, we would like to thank Michael and Judy Bornfeld and John and Jennifer Montin for granting the easements on their property required to build the well system. And Harvey VanDyke (Chairman retired) for his tireless effort that frankly, made this project possible. We have received full payment from the DWR (California Department of Water Resources) that paid for half of the well cost. The remaining half was a loan taken from the Pinon / Rimrock water system and is still in the process of being re-paid. There are currently no plans of an increase to your yearly connection fee.

**Your assistance** – As always, please **notify us immediately** if you perceive any change in the odor, taste or clarity of your water.
