## **Great Work but...The Drought is Not Over!**



The Wheeler Crest Community Services District would like to **thank all of you** for your effort in reducing our water usage this past year. We are under a State mandate to reduce water consumption by 25%. Being a small community service district, individual monitoring is not mandated. Thanks to all in helping to achieve an **overall reduction of 31% (2014 vs. 2015)** for the Pinon/Rimrock water system.

This past year has been challenging for all, especially with the desire to replant and be surrounded by some sense of "normal" vegetation. Although this winters' snow level is "normal", we are still way below the amount of water/snow required to pull us out of this drought. So we thank you for remaining vigilant in your water conservation effort. We would like to remind you that come spring, the mandatory restriction of outdoor watering is still limited to two days. You will be notified if this restriction is lifted.
